OUR PRIVACY PLEDGE TO YOU.

Your relationship with ASI is based on trust and confidence. To fulfill its responsibilities to you, ASI Firm requires that you provide current and accurate information.

You deserve to expect that ASI will protect the information you have provided in a manner that is safe, secure and professional. ASI and its employees are committed to protecting your privacy and to safeguarding that information.

Site Usage

This is a private site used and owned by the Alliance for Strategic Intelligence, LLC. By being here, you consent to full confidentiality and privacy stipulation of ASI, LLC, its affiliates and providers. No information on this site can be used, published, transferred and/or delivered in any known and unknown fashion throughout the universe without the full written consent of the CEO/Executive Director of ASI, LLC. Any users of this site that cannot adhere to ASI, LLC privacy and confidentiality request are asked to leave this site immediately.

Research & Development Division

Our Research & Development Department consist of "Finders", Scientist, Intel Specialist, Domestic & Foreign Policy Interpreters, Global Translators (All Languages), Economist, Historians, etc. The R&D work we provide is held to the highest level of confidentiality. We employ several levels of protective systems, to safeguard this information. Depending on the nature of work, ASI conduct background and security check on all employees operating in such areas NO EXCEPTIONS!

Safeguarding Staff & Member

During regular business hours, a registered principal will ensure that access to customer records is monitored so that only those with approval may access the files. During hours in which the company is not in operation, the customer records will be locked.

No individual who is not so authorized shall obtain or seek to obtain personal and information of our staff or clients. No individual with authorization to access personal information will share that information in any manner without the specific consent of an ASI, LLC principal.

Failure to observe ASI procedures regarding Staff and Client privacy will result in discipline and may lead to termination and/or internal investigation.

Patriot Act

The Patriot Act requires ASI Institute to verify the identity of person(s) Clients, Members of Foreign domicile or Non-American Citizenship.

Including but not limited to:

Consulting government agency lists of known or suspected criminals, terrorists and terrorist organizations to determine if the person opening an account is on any such list; and If necessary, conducting additional due diligence including requesting information about the source of funds allocated to the purpose of ASI, LLC.

ASI, LLC works as a private firm and a contracted affiliate of the US Government. All information obtained by ASI Staff, Member Services, Confidential Field Members, Informants or Agents is the sole property of ASI, LLC. At time-to-time ASI may associate with various Government Agencies in an event to provide needed information for the purpose of Global safety. At times, ASI may swap services in exchange for information. Under no circumstances do ASI associations with these Agencies conflict with the safety, privacy and/or mission of ASI, LLC unless criminal practices are activated.

At times, ASI has internal agents providing investigative services of both Domestic and/or Foreign intel. These jobs are performed under the protection of those Governing Agencies, in addition to ASI's Protective Services Division.

Governing Rules of ASI Firm

- 1.) ASI operates as an information based firm.
- 2.) ASI is a private firm.
- 3.) ASI has direct affiliation or association with any the US Government.
- 4.) ASI performs its services on an international base.
- 5.) ASI guarantee's it information's accuracy.
- 6.) ASI reserves the rights to all info provided to us.
- 7.) ASI is not required to share this info with NO outside entity.
- 8.) ASI Agents work in conjunction with Local, State, Federal and International Government.
- 9.) Only licensed ASI Agents has the right to carry a firearm.
- 10.) All Employees' of ASI are required to undergo random drug screening.
- 11.) All Field Rep's identities, Domestic and Foreign , are held to the utmost privacy.
- 12.) ASI has a strict "Truth in Information Order" based program.
- 13.) All Employees' are held to the strictest of discretion about ASI programs.
- 14.) ASI Clients are not held to the same discretion, unless specifically stated.

Protective Services Division

ASI's Agents or Protective Services Division provides both Domestic and Foreign protective services. In our line of business, from time-to-time, we may encounter those person(s) who deem our services as threatening and/or intimidating. These groups or individuals may choose to invade, violate or attack our Staff or Members. It is at this time that we employ PSD Agents to intervene, in order to establish protection and safety of our Staff, Clients and Members; for the integrity of our mission and our overall objective.
